Assembling and Correlating Indirect Evidence for the Identities of the Parents of Edward Sheehy (1859-1894)

Family tradition names the parents of Edward Sheehy as John Sheehy and Mary Broder, both born in Ireland.¹ Edward's New York City baptism extract is the only known record confirming those names.² Nothing more is known about his parents. The evidence establishing the identities of John and Mary (Broder) Sheehy comprise many strands of unconnected information that come together in the family's hidden final resting place.

INTRODUCTION

Edward Sheehy, a first-generation American of Irish-born parents, came of age in the Lower East Side of Manhattan during the latter half of the 19th century among tenements teeming with European immigrants. His parents, John Sheehy and Mary Broder, were part of the huge wave of Irish immigrants who settled in New York City in the mid-19th century. The great famine in Ireland may have brought them to America, not just for a better life but for survival. But who were they, as unique individuals? When were they born, where did they live, what did they do for a living? When and where did they die? Answering these questions transforms names into real individuals and is a prerequisite to trace their Irish origins.

The process of putting flesh on the bones of mere names is often a challenge, and particularly so in New York City, which has a reputation as "the black hole of genealogy." While that reputation is overstated, there are many challenges facing the researcher seeking documentation for people who lived in 19th century New York City. The massive population growth from the vast numbers of immigrants continuously arriving to the city (from a population of half a million inhabitants in 1850 to almost 3.5 million by 19004) strained the record-keeping capabilities of the jurisdictional authorities, allowing people to fall through the

cracks with no enforcement or motivation for compliance. Records were maintained at several different jurisdictional levels (federal, county, municipal), further complicating research. The New York State census, taken every 10 years between the U.S. Federal census years, is not available for New York County (Manhattan) for 1865 and 1875,⁵ two key years for that major municipality. Relatively few vital records of this time period are computer-indexed and the contemporaneous indices often require knowledge of the approximate date of the event. The dense urban population created an environment where numerous people shared the same common names, and multiple people had the same less common names. Compounding that issue is the minimal information recorded on many of the early records, making it very difficult to distinguish between people sharing the same name.

For these reasons, a typical "search and find" research methodology often will not be successful in 19th century New York City. The pursuit of the identities of the parents of Edward Sheehy illustrates the process of accumulating bits and pieces of potential information from multiple sources, analyzing them for consistencies and conflicts, and piecing them together to create a whole story.

BACKGROUND INFORMATION

Edward Sheehy was born 18 June 1859 in New York City, the son of John Sheehy and Mary Broder.⁶ He married Catherine "Kate" Dobbins 29 March 1881 in New York City⁷ and they had the following children:

- John (1880-1882)⁸
- Edward Jr. (1883-1922)⁹
- Mary (1885-1947)¹⁰

- Catherine (1887-1892)¹¹
- Thomas (1889-1919)¹²
- James (1891-1893)¹³
- Richard (1895-1924)14

Edward had at least one sibling, John Sheehy, born 1861 in New York City. 15

CENSUS STARTING POINTS

Censuses capture entire family groups at specific moments in time and across time periods and help identify families when few details are known, therefore, they are a prime starting point to research Edward's parents. Searches of U.S. federal census records for New York City using criteria compatible with the target family¹⁶ presented the following candidates for Edward's family.

The 1860 U.S. Census

Only one family enumerated in the 1860 census in New York City reported details consistent with the target family:

Edward's expected age and known birthplace, as well as the given names and birth places of his parents, are consistent with this census record. The recorded name of Sheehan, a common Irish surname, could sound similar to Sheehy to an enumerator's ears.

Unexpected in the family is 13 year old Cornelius. Born in Ireland, he may be a relative or perhaps John's son from a previous marriage.

Due to the very common given names (John and Mary) and the name of Sheehan instead of Sheehy, this census record requires additional evidence to confirm this family as Edward's.

The 1870 U.S. Census

Only one family enumerated in the 1870 census in New York City reported details consistent with the target family:

The 1870 census family matches the target family exactly, with the exception of the adult female named Bridget instead of Mary, and a slight variation in the spelling of the surname. To confirm this family as Edward's requires additional evidence. Specifically, confirmation that Mary (Broder) Sheehy died and/or that John remarried a Bridget would support the hypothesis that this census record is Edward's family.

The 1880 U.S. Census

Only one family enumerated in the 1880 census in New York City reported details consistent with the target family:

This family is very likely the same family in the previously described 1870 census despite the nineteen year difference in John's reported age between the two censuses, which may be due to an informant who didn't know John's correct age or an error by the enumerator. Son John, at age 19, was probably on his own and no longer living with his family. As with the 1870 census, the 1880 census requires additional evidence to confirm it as Edward's family.

It isn't clear if these three census families are Edward's or even if they are the same family, but they are potential candidates and provide a basis for additional research. That research includes determining if the Mary Sheehy of the 1860 census died, if John Sheehy later married a Bridget, and a linkage to the subject Edward Sheehy.

THE DEATH OF MARY OF THE 1860 CENSUS

Confirming the death of the Mary "Sheehan" of the 1860 census between the time of that census' enumeration and the 1870 census would provide additional support that this could be the same family found in the 1870 and 1880 census with a new wife for John. Searches of a New York City death database using criteria specific to the target Mary Sheehy presented the following candidates:²⁰

- Mary Sheehy, age 43, died 03 Feb 1864, address 33 James
- Mary Scheehan, age 48, died 11 Jun 1864, address 432 1st Ave.
- Mary Sheehan, age 48, died 07 Apr 1866
- Mary L. Sheehan age 38, died 13 Apr 1866
- Mary Sheehan age 35, died 24 Mar 1870

Although the 1860 census does not include an address to compare to these candidates, a correlation of indirect evidence identifies the census address. The census reports the names and occupations of the neighbors residing in the same dwelling as John and Mary Sheehy. The 1861 New York City directory includes entries for four of those neighbors, all residing at 33 James Street,²¹ establishing that address as the address of the 1860 census Sheehy family.

The first Mary Sheehy death entry of the potential candidates listed above shares that address and a fairly close birth year with the Mary Sheehy of the 1860 census record, confirming that the Mary Sheehy who died on 03 February 1864 is the same Mary in the 1860 Sheehy family census record. The Manhattan death register for this Mary Sheehy does not include a spouse's name or her maiden name²² so there is no additional support that the 1860 census family is Edward's family, but her confirmed death opens a potential path to tie the 1860 census Sheehy family to the 1870 and 1880 Sheehy family, where John has a different wife.

DIGGING DEEPER INTO THE 1870 & 1880 CENSUS FAMILY CANDIDATES

The candidate family in the 1870 census is very compatible with Edward's expected family:

- The pair of siblings, Edward and John, matches the target family in name, age, and birthplace.
- The father's name and birthplace match those of the target family.
- One conflict, the adult woman's name of Bridget instead of the expected Mary, may be due to Mary's death and John's subsequent remarriage.

The following considerations provide support that the family in the 1880 census is the same family as in the 1870 census:

- A trio of family members (John, Bridget, and Edward) is together in both census years, with compatible birthplaces.
- The calculated birth years for Bridget and Edward are approximately consistent between both census years. John's age difference of 19 years instead of 10 years may be due to an informant who didn't know John's correct age or an error by the enumerator.
- John's occupation is consistent across the two decades:
 - The 1880 census reports the Sheehy family living at 45 James Street and John's occupation as "grocer."
 The city directory entries for 1879, 1880, and 1881 for John

- Sheehy at the same address list his occupation as "grocer," "pedlar," and "variety," all indicating a seller of goods.
- o In the 1870 census the Sheehy family is living at 22 Madison Street with John's occupation as "peddler."²⁵ The city directory entries for 1865 through 1873 for John Sheehy at the same address list his occupation variously as "grocer," "pedlar," "varieties," and "vegetables".²⁶

Absent in the online marriage indices for New York City is a reference to a marriage occurring between 1861 and 1870 for John Sheehy and a woman named Bridget or Delia (a nickname for Bridget). While such a record would support the hypothesis that these census records are Edward's family, its absence does not indicate that the marriage did not take place. Relatively few New York City marriage records are computer-indexed for this time period and the earliest years of that range do not even have contemporaneous indices, making it necessary to have knowledge of the approximate date of the event. With the potential marriage date range spanning nine years, that is an impractical research task in such a densely populated urban city.

A newspaper death notice reports the death of John Sheehy of 45 James Street (the same address as in the 1880 census) on 12 November 1881.²⁸ His death certificate does not offer any additional evidence to confirm him as Edward Sheehy's father.²⁹

While the census and other records described above are consistent with known information about Edward Sheehy's family, they do not provide definitive evidence to conclusively tie them to the subject Edward.

A HIDDEN FINAL RESTING PLACE

The death register entry for Mary Sheehy of the 1860 census and the death certificate for John Sheehy of the 1870 and 1880 censuses report burial locations in Calvary Cemetery.³⁰ Calvary Cemetery office records indicate both burials are in the same plot,³¹ establishing that the families from the three census years (1860, 1870, and 1880) are the same family. There are no grave markers on this plot³² thus the only recorded details of their burials here are in the office files of the cemetery. An analysis of the interment list for this burial plot ties all parties together.

- The burial plot contains the graves of Mary Sheehy of the 1860 census and John Sheehy of the 1870 and 1880 censuses, suggesting a close family relationship, almost certainly husband and wife, as they lived together in 1860 with child Edward, and John Sheehy was the purchaser of this burial plot at the time of Mary's death.⁴⁰
- The burial plot contains the graves of three young children of Edward Sheehy and
 Catherine Dobbins, strengthening the case that the John and Mary Sheehy buried here
 are Edward's parents. The burial of Edward's young children here after the death of the
 Ireland-born John Sheehy implies that Edward acquired the deed to the cemetery plot,
 doubtless handed down to him after the death of his father.
- The interment here of Edward's brother, the junior John, further confirms that this is Edward's family. This interred John's death certificate, while it does not provide his mother's maiden name, is compatible with Edward's brother John in name, calculated birth year, birth place, parents' names and parents' birth places. Furthermore, the junior John's place of death was 24 Willow Terrace, Hoboken, New Jersey, the same address where Edward and Catherine Sheehy lived in 1891.⁴¹

SUMMARY

The correlation of indirect evidence revealed the identities of Edward's parents. His mother, Mary Broder, was born in Ireland around 1825. She died in New York City 03 February 1864, leaving her husband with two small boys, Edward and John, and probably an infant son, James, who died just weeks after his birth.

Sources agree on Ireland as John Sheehy's place of birth, but reports of his birth year vary widely, not uncommon for illiterate immigrants during this time period. A credible birth year for him is around 1825. After Mary's death he married a Bridget, who helped him raise sons Edward and John junior. John worked as a seller of goods (grocer, peddler, varieties, vegetables) during his time in Manhattan, where he lived from at least 1859 until his death on 12 November 1881. His death certificate reports his parents as John and Margaret Sheehy.

CONCLUSION

When little more than a name is known, the process of accumulating and correlating indirect evidence can reveal the identity of a person. A synergetic combination of church documents, censuses, vital records, city directories, and cemetery records confirmed the names of Edward Sheehy's parents and established their identities.
